Efficiency Heating & Cooling reserves the right to pre-inspect your residential heating and cooling prior to acceptance in the Efficiency Home Protection Plan. A diagnostic fee may apply to equipment failing to pass pre-inspection. Unless the membership is a continuation of an existing Efficiency Home Protection Plan, the activation date is the date that the heating and cooling system has been approved for acceptance and payment has been received by Efficiency Heating & Cooling. Efficiency Heating & Cooling is not bound to undertake additional preventative or ongoing maintenance other than the furnace or air conditioning maintenance provided as part of the program. Efficiency Heating & Cooling will respond as provided by the level of Efficiency Home Protection Plan.

Efficiency Heating & Cooling carries a large inventory of replacement parts for most heating and cooling equipment. In the event that a part is unavailable, we will attempt to obtain a replacement part or an equivalent substitute as quickly as possible. Parts replacement is solely at the discretion of Efficiency Heating & Cooling. In the unusual event that we cannot provide a part replacement, Efficiency Heating & Cooling reserves the right to refund your entire fee for that current year without notice or liability to the Efficiency Heating & Cooling.

If you move, coverage for the balance of the term will remain with the equipment and is transferable to the new owner. A \$25.00 Administration fee will apply. Please notify Efficiency Heating & Cooling of the new ownership of the Efficiency Home Protection Plan.

The Efficiency Home Protection Plan does not cover any damage caused by abuse, theft, vandalism, fire, flood, earthquake, other natural disaster, and acts of war or acts of God. The heating and air conditioning company reserves the right to discontinue the Efficiency Home Protection Plan at any time. In the event of cancellation of the plan, Efficiency Heating & Cooling liability is restricted to a refund, if any of the unexpired portion of the fee payments. Enrollment in the Efficiency Home Protection Plan is subject to the company receiving payment as contracted.

The Efficiency Home Protection Plan does not include the turn on or turn off of equipment, balancing of systems, deliming of water boilers, ducts or radiators, draining / filling un-valved expansion tanks, or any other service considered plumbing, sheet metal or electrical work on housing wiring. Air Conditioning: Plan valid on central air conditioners only. Window air conditioning is not eligible. Plan not valid on commercial air conditioning units or residential air conditioning units in commercial applications.

Cooling only plans include repair only to the air conditioning condensing unit and coils consistent with the above terms and conditions. Repairs required within the furnace or air handler are not covered by cooling plan but are included in the joint heating and cooling plan.

Accessories: Humidifiers, Electronic Air Cleaners, Media Air Cleaners, Condensate Pumps, Hot Water heaters are also eligable for Home Protection Plan coverage provided the accessory is in acceptable working order upon plan inception. Accessory pricing includes maintenance and replacement of humidifier pads and pleated filter media, an part replacement as necessary.

Specialty equipment: Will be covered at the Silver Membership Level only. Includes but is not restricted to: Ductless Split Air Conditioning, Heat Pumps, Gas Boiler, Fireplace, Spacepac, Waterfurnace, Outdoor Pool Heater, HRV. Individual pricing will be quoted for each piece of specialty equipment.
